Your Dues Investment Is Assessed At 33% Of Your Full Dues For The First Year, 66% Of Your Full Dues For The Second Year and Full Dues Investment For The Third Year. **PLEASE NOTE: Two different formulas are used in calculating your ACEC (National) and Texas CEC dues. ACEC DUES ARE NOT INCLUDED IN THE CHART BELOW AND MUST BE CALCULATED SEPARATELY.***

**IF YOUR HEADQUARTER OFFICE IS PAYING NATIONAL DUES DIRECTLY TO ACEC, THE CHART BELOW REPRESENTS TOTAL DUES OTHERWISE, YOUR TOTAL DUES WILL INCLUDE TEXAS CEC DUES PLUS NATIONAL DUES.**
